<p>Outreach, Education and Prevention/Awareness Programming</p>	<p>The UAA Dating Violence and Sexual Assault Coalition for Change is a group that consists of students, staff, faculty and community partners to discuss and plan ways to fight and raise awareness of sexual assault and dating violence on campus. The coalition meets monthly and is open to anyone that wants to be involved.</p> <p>New prevention staff have been hired by the Dean of Student’s Office, and will be in place in August. Plans are in place for the partnership between the Office of Equity and Compliance and Prevention as an initial meeting will take place in August, with ongoing meetings throughout the year.</p> <p>Campus Kick-Off takes place on August 27, where there will be a resource booth for the Office of Equity and Compliance to include all of the OEC staff.</p> <p>New OEC fliers have been developed to distribute amongst all of the UAA campuses.</p>
